

MINUTES OF 48TH MEETING OF THE CENTRAL INSECTICIDES BOARD (CIB) HELD ON 26.06.2013 at RESOURCE CENTRE, ROOM NO. 445, 'A' WING, NIRMAN BHAWAN, NEW DELHI.

The 48th Meeting of Central Insecticides Board (CIB) was held on 26.06.2013 at 10.30 AM at Resource Centre, Room No. 445, 'A' Wing, Nirman Bhawan, New Delhi under the chairmanship of Dr. Jagdish Prasad, Director General of Health Services, Ministry of Health & Family Welfare. Since the quorum was not complete, the meeting was adjourned for thirty minutes and reconvened at 11.00 AM. The list of the participants is at **Annexure-I**.

The Chairman welcomed the participants and requested the APPA and Secretary, CIB & RC to present the agenda. After detailed deliberation on each issue in the Agenda, following decisions were taken: -

Agenda Item No. 1: Confirmation of minutes of 47th meeting of CIB held on 26.12.2012

As no comments were received, the minutes of 47th meeting of Central Insecticides Board were confirmed.

Agenda Item No. 2 : Follow up action on the decisions of 47th meeting of the CIB.

The Board noted the follow up actions on the decisions of 47th meeting with satisfaction.

Agenda Item No. 3 : Progress report of the Registration Committee, Central Insecticides Laboratory and Regional Pesticides Testing Laboratories.

I. Registration Committee:

The Board noted the progress of the Registration Committee with satisfaction. While discussing export registration, Chairman opined that Registration Committee should ensure safety of factory workers, as well as environment.

Secretary (CIB&RC) clarified that for registering new molecules exclusively for export purpose, we require information about the toxicity of the product and not the data as per guidelines of Registration Committee. Expert toxicity further elaborated the issue.

II. Central Insecticides Laboratory (CIL):

The Board noted the progress of the CIL with satisfaction. Chairman desired that all the divisions should undertake the mandated work as per the provisions under the Insecticides Act, 1968.

III. Progress report of Co-ordination Cell at Headquarter, Faridabad:

The Board noted the progress of the Co-ordination Cell with satisfaction. Chairman emphasised that more number of samples should be drawn to ensure supply of quality pesticides to the farmers and defaulters be executed in court of law as per the relevant provisions under the Act.

Agenda Item No. 4: Application for inclusion of substances in the Schedule to the Insecticides Act, 1968.

The board deliberated the agenda in detail and decided to include Metazosulfuron in the Schedule to the Act as proposed at Sr.No.01 (**Annexure – II**) and the molecules at Sr.No.02, 04 and 05 in Annexure – VI of Agenda were deferred for want of information on the deficient parameters as per the requirement for inclusion in the Schedule to the Act.

In respect of molecule proposed at Sr.No.03, in Annexure – VI; Board decided that clarification may be sought from the applicant regarding its exact chemical name to be included in the Schedule. After duly scrutiny by the concerned experts, if clarification found satisfactory, the case may be put up on file to the Chairman, Central Insecticides Board, for approval of the chemical for inclusion in the schedule.

Agenda Item No. 5 : Waiting period/pre-harvest interval between application and harvest w.r.t. New Formulations u/s 9(3) and label Expansion of already registered formulations..

Noted.

Agenda Item No. 6 : Any other item with the permission of Chair.

Agenda (Addl.) : Consideration of applications for inclusion of combination products in the Item No. 6.1 Schedule to the Insecticides Act, 1968.

The Board deliberated the Agenda Item in detail and accepted the recommendations of the Committee which are as under:

- (i) Individual substances may only be considered for inclusion in the Schedule and their combination in preparations (formulations) may be allowed at the time of registration, provided the scientific data proved their compatibility, efficacy, safety, etc. as per the guidelines

of the Registration Committee. Combination products may not be included in the Schedule.

- (ii) Existing mixture of EDCT may be removed from the Schedule as its individual components are already included in the Schedule.
- (iii) Trade names and Code numbers of the substances included in the Schedule may be replaced by Common names and in future inclusion may be allowed only with the common names.

**Agenda (Addl.)
No. 6.2**

: Enhancement of shelf life of Diuron 80% WP from one year to Item two years.

Agenda was discussed in detail and decided to grant permission to M/s Makhteshim Agan India Pvt. Ltd, for generation of data as per guidelines of RC, for enhancement of shelf-life of Diuron 80% WP from one year to two years as proposed in the Agenda.
